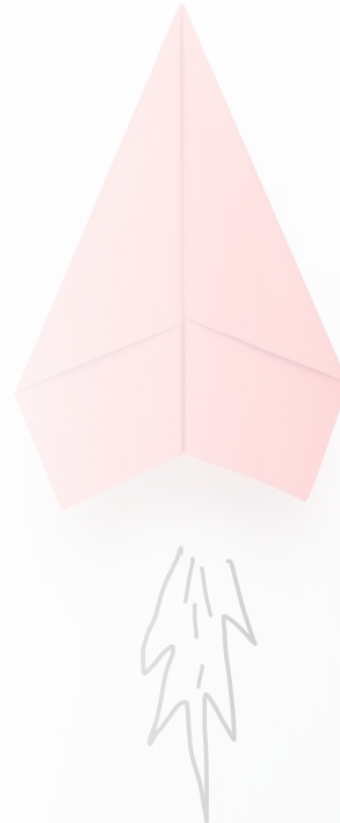
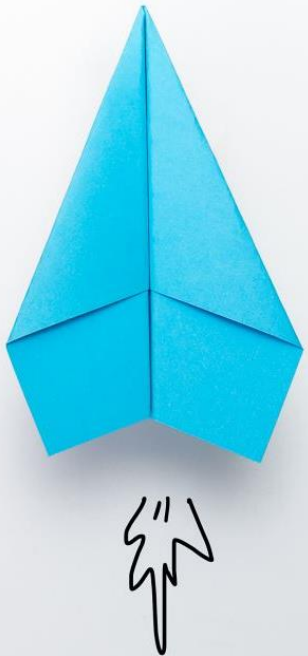
Domestic Clean Heat & Insulation


ECO3 Scheme

- Current funding until March 2022
- Available for low income households
- Social landlords can apply for funding to improve housing stock with EPC band E,F & G (EPC rating band D may also be eligible for innovation measures)
- Funding available through energy suppliers for insulation measures and in some cases heating systems

Clean Heat Grant

- The Clean Heat Grant will begin in April 2022 for 2 years
- Upfront grant scheme of £4000
- Heat pumps and some biomass in domestic and commercial installations up to 45kW.
- Not available for heat networks, hybrid systems, process heating, biogas combustion or solar thermal





Domestic Clean Heat & Insulation (Continued)

Domestic Renewable Heating Incentive

- Available for biomass boilers, solar water heating, air source heat pumps (ASHP) and ground source heat pumps (GSHP)
- Funding available until 31st March 2022
- Receive quarterly payments for 7 years for amount of “clean heat” the system produces
- Only for use where renewable technologies are installed on existing homes

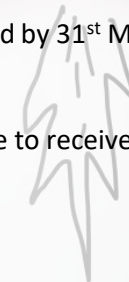
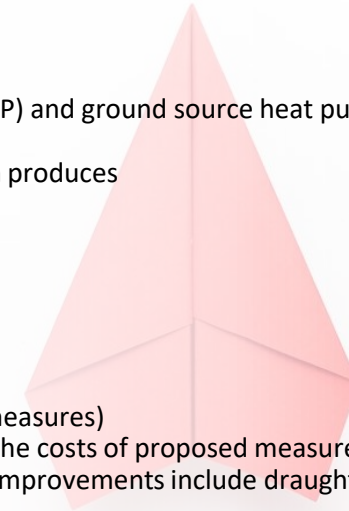
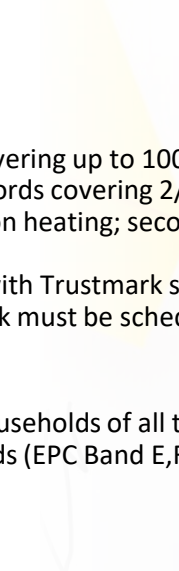
Green Homes Grant

Voucher scheme for households

- Grants of up to £10,000 for low income households (covering up to 100% of measures)
- Grants of up to £5000 for homeowners and social landlords covering 2/3rd of the costs of proposed measures
- Primary improvements include insulation and low carbon heating; secondary improvements include draught proofing, windows and doors, and heating controls/insulation.
- Improvements are made through registered suppliers with Trustmark scheme
- Vouchers available from the end of September and work must be scheduled or completed by 31st March 2021.

LA delivery scheme

- Only Local Authorities can apply for the scheme, but households of all tenures are eligible to receive the funding
- Funding targeted at the least energy efficient households (EPC Band E,F or G)





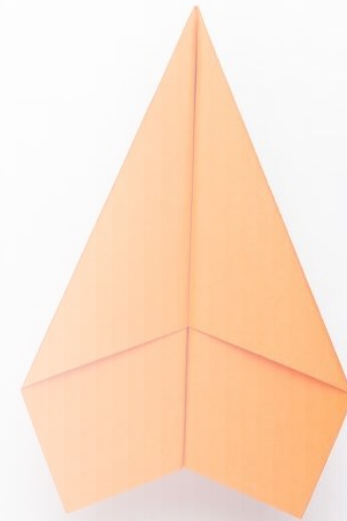
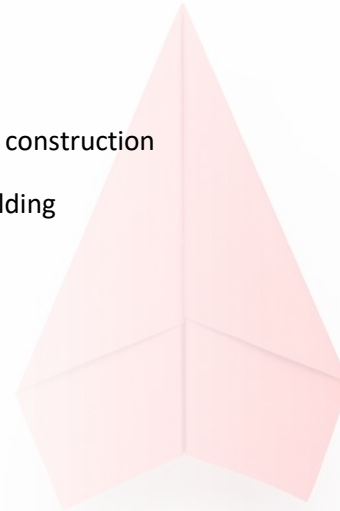
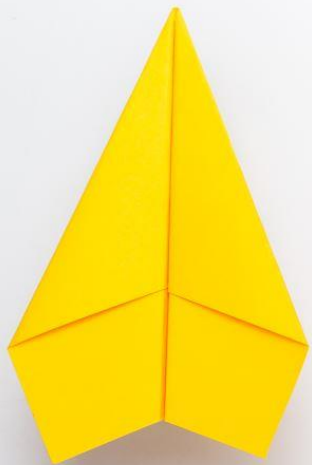
Heat Networks

Heat Network Investment Project

- HNIP funding is available between March 2019 and March 2022
- Grants of up to £5 million – to cover up to 50% of capital cost of construction
- Grants for heat network sponsors or owners
- Networks must provide heating or cooling to more than one building
- Must deliver carbon savings

Green Heat Network Scheme

- Available from 2022-2025
- £270 million capital grants
- Available for both existing and new heat networks
- Focusing on waste heat and other low carbon sources of heat





Other Available Funding

Green Gas Support Scheme

- Starting Autumn 2021
- Available to new applicants for 4 years on an indicative 15-year tariff period
- Supports biomethane through anaerobic digestion

Social Housing Decarbonisation Fund Demonstrator

- £50million programme
- Launching in October 2020 for grants to be awarded in December 2020
- Available to learn lessons ahead of the £3.8 billion Social Housing Decarbonisation Fund which will be allocated in Autumn spending review
- Open to LA's for work on their retained housing stock and/or HA or ALMO stock
